

Product description/Product definition

The dormakaba access manager 92 00 fulfils all the requirements of modern security systems. With its intelligent decision logic and ability to be freely parametrised, it can control simple types of access points as well as more complex entrances to highly sensitive areas. Based on the latest operating system and transport layer security (TLS) encryption between the controller and host system, the IT security is state-of-the-art. With integrated mobile access, the access system allows access via smartphone. The control electronics integrate everything that is required to enable a connection to cloud services via IoT. With its flexible and extendable design, it offers a wide range of installation options. It can be installed locally as an individual device near an access point, in switch cabinets or centrally with extended input/output modules. Up to two registration units can be connected directly and further access readers via the RS-485 sub-bus. For the placing on the market in the European Union/European Free Trade Association (EU/EFTA) (with the exception of Switzerland) the following legal provisions apply:
