### Reference service life

The life cycle of the ESA 500 door system is about 10 years, depending on the application and frequency of use. Regular maintenance is advised to ensure a life expectancy of 10 years. For repairs or renewals, suitable spare parts are available. The drive is tested to 1,000,000 closing cycles according to EN 16005.
