

Kooltherm® K8 Plus is a rigid thermoset cellular insulation material faced on both sides with a composite foil based facing. On the backside a mineral wool (20 mm) is bonded. The product is available in variable thicknesses from 20/20 mm up to 200/20 mm. This EPD covers one of the most commonly sold thickness of 100/20 mm with an $R_{\text{D}}\text{-value}$ of 5,6 $\text{m}^2\text{-}\text{K/W}$.

Due to its high insulating value, Kooltherm® K8 Plus is suitable for use as cavity wall insulation. The extra layer mineral wool (20 mm) will absorb unevenness in a construction, which makes Kooltherm® K8 Plus suitable for renovation projects.

Base materials/Ancillary materials

The main materials are phenolic (PF) resin (between 70-80%) with added catalyst and additives (between 15-20%). Phenolic rigid foam onto a facing material (between 5-10%) is formed by the chemical reaction of these materials and adding a blowing agent with no ozone depletion potential (ca. 5%). Due to the closed-cell structure (conform *EN 13166*), the blowing agent remains in the foam. In the

current *REACH* regulations, phenolic foam insulation products are considered "articles" and are exempt from

the requirements of Article 57 and 59(1) of *REACH* Regulation (EC) No 1907/2006. These products are not classified as "hazardous products" according to any current legislation, and can hence be declared as follows:

- This article contains substances listed in the candidate list (date: 19.01.2021) exceeding 0.1 percentage by mass: **no**.
- This article contains other carcinogenic, mutagenic, reprotoxic (CMR) substances in categories 1A or 1B which are not on the candidate list, exceeding 0.1 percentage by mass: **no.**

Renewable electricity sources for manufacturing

All electricity used during production comes from renewable sources.

By generating energy on-site with solar panels and with procured energy from fully certified renewable sources. Following the global Net Zero Energy strategy from Kingspan Group plc.

Comparability

Basically, a comparison or an evaluation of EPD data is only possible if all the data sets to be compared were created according to *EN 15804* and the building context, respectively the product-specific characteristics of performance, are taken into account.
